



These terms and conditions (the “Terms”) apply to your registration for and attendance of **CrowdStrike Government Summit** (the “Event”), and constitute an agreement between CrowdStrike, Inc. By registering for and/or attending the event, you acknowledge and agree that you: (a) have read and understand all of these terms; (b) agree to be legally bound by all of these terms; and (c) if you are representing an entity, you have the authority to represent such entity. If you do not agree to all of these terms, do not register for or attend the event.

Registration

CrowdStrike Government Summit is a private event designed for CrowdStrike customers, government agencies, CrowdStrike partners, industry professionals and invited guests. Event registration is subject to CrowdStrike’s approval. Unapproved registrations will be canceled with a full refund. To register for the Event, you must complete the Event registration process and pay all required registration fees (if applicable) prior to any deadlines described on the registration page for the Event. Cancellation By Us

CrowdStrike may cancel the Event at any time and may deny, limit or cancel a registration for the Event (including a confirmed registration) at any time. Force Majeure



CrowdStrike shall not be held responsible for any delay or failure in performance of its obligations hereunder to the extent such delay or failure is caused by fire, flood, strike, civil, governmental or military authority, acts of God, acts of terrorism, acts of war, epidemics, the availability of the venue or other similar causes beyond its reasonable control and without the fault or negligence of CrowdStrike or its subcontractors (a "Force Majeure Event"). For one or more Force Majeure Events, CrowdStrike may postpone, reschedule or cancel the event without liability on the part of CrowdStrike. If the Event cannot be held or is postponed pursuant to this section, CrowdStrike shall not be liable to attendee for any damages, costs, losses, or other financial losses, such as transportation costs, accommodations costs, or financial losses.

Liability

IN NO EVENT SHALL (A) CROWDSTRIKE BE LIABLE FOR ANY LOSS OF DATA, LOSS OF PROFITS, LOSS OF OPPORTUNITY, COST OF COVER OR OTHER SPECIAL, INCIDENTAL, CONSEQUENTIAL, INDIRECT, PUNITIVE, SPECIAL, EXEMPLARY OR RELIANCE DAMAGES ARISING OUT OF OR RELATING TO THE TERMS OR THE EVENT, UNDER ANY LEGAL THEORY, EVEN IF CROWDSTRIKE KNOWS OF OR SHOULD HAVE KNOWN THE POSSIBILITY OF SUCH DAMAGES, OR (B) THE AGGREGATE LIABILITY OF CROWDSTRIKE TO YOU FOR ALL OTHER DAMAGES IN CONNECTION WITH THE EVENT EXCEED THE GREATER OF: (I) \$50, OR (II) THE FEES PAID BY YOU FOR THE EVENT. To the extent permissible by applicable law, you (for yourself, your heirs, personal representatives, assigns, and anyone else who might make a claim on your behalf) hereby release CrowdStrike and its affiliates, and their respective directors, officers, employees, contractors, representatives, agents, successors and assigns, from any and all claims, demands, causes of action, suits, damages, losses, debts, liabilities, costs and expenses (including without limitation reasonable attorneys' fees and costs) that you may have now or in the future associated in any way with the Event.

Miscellaneous

The Terms shall be governed by and construed in accordance with the laws of the State of California and the parties hereby consent to the jurisdiction of California's courts over all matters relating to these Terms. This Agreement constitutes the complete agreement between the parties and supersedes all prior or contemporaneous agreements or representations, written or oral, concerning the subject matter hereof. This Agreement may not be modified or amended except in a writing signed by a duly authorized representative of each party.
